## Tips from Iowa Grantmakers

- Do your homework.
- Find your match.

- Tell your story. And make sure others can tell it, too.
- Ask about the review process.
- Ask about other support.

## Tips from Iowa Grantmakers

- Follow the rules.
- Allow time to do the application.
- Articulate your needs.
- Hire a grantwriter? Maybe.

## **Tips from Iowa Grantmakers**

If grant is secured ....

- Say thank you.
- Use the money.
- Report back. Be honest.

If the funder says no ...

- Say thank you.
- Ask for feedback.
- Keep trying to build the relationship.

## Endow Iowa Tax Credit Program

25 percent tax credit for ....

gifts to permanent endowed funds held at qualified community foundations

for the benefit of Iowa charitable causes (such as your organization)

## Endow Iowa – New this Year!

- Tax credit base increased to \$6 million
- \$300,000 limit per individual
- (2012) 3,075 donors; nearly \$5.8 million in credits awarded; over \$23 million in charitable gifts leveraged

#### **County Endowment Fund Program**

To increase philanthropic activity to enhance quality of life for all lowans

Equal distribution of % of commercial casinos' gaming tax revenues among counties that do not hold state-issued gaming license.

75% re-distributed in grants; 25 % builds permanent endowment for future grants
